#### 2. HAZARDS IDENTIFICATION

**2.1. Classification:** Not applicable.

## 7. HANDLING AND STORAGE

#### 7.1 Handling:

Special technical measures are not necessary. When is used and handled according to specification, the product does not have any harmful effects, according to our experience and the information provided to us. Handle with adequate ventilation for dust.

#### 7.2 Storage:

Store in a dry place.

Recommendation: Follow instructions of grinding machine manufacturers and the relevant national regulations. In addition, observe the safety recommendations of the manufacturer. See FEPA regulations -Safety Code-European Safety Regulation for correct using of wheels.

## 8. EXPOSURE CONTROLS / PERSONAL PROTECTION

**8.1. Control parameters:** Before grinding it is recommended to perform a risk assessment and to use personal protection equipment accordingly.

## 13.1. Waste treatment methods

- **15.1. Safety, health and environmental regulations/legislation specific for the product:** No specific labelling requirements under respective EC directives.
- 15.2. Chemical safety assessment: Not relevant.

#### 16. OTHER INFORMATION

During the last years WEILER ABRASIVES d.o.o. provided information on our abrasive products on a voluntary basis in the format of a safety data sheet.

Under the REACH Regulation the status and importance of the safety data sheet has changed. Safety data sheets are documents with a legally defined scope which have to fulfill certain requirements related to the format and content (Annex II of the REACH Regulation). Following the REACH Regulation the communication of important information via Safety Data Sheets (SDS) is only foreseen for substances and mixtures. For articles a safety data sheet is not foreseen under REACH.

Abrasive products meet the criteria of articles according to REACH with exemption of polishes and pastes which are defined as mixtures or substances. Consequently no safety data sheets have to be provided by abrasive producers for most of their products.

However, many customers of the abrasive industry are used to the format and structure of a safety data sheet and prefer the communication of information on abrasive products in this form.

Therefore the abrasive industry decided to continue to provide this voluntary information on a safe use and handling of abrasives in form of a

"Voluntary Product Information (VPI) based on the format of a safety data sheet".

This voluntary product information follows the general structure of an SDS (16 sections). But as certain sub headings are not relevant due to the article status of abrasives these are not included.

Please be aware that the provision of these documents is a voluntary service. There is no requirement for the abrasive industry to provide this document.

We hope that this decision of the abrasive industry is in line with your internal quality requirements.

The product does not contain:
