## LIMITED ONE YEAR WARRANTY

Functional hardware products distributed by Euro (collectively, the “Products”) are warranted to the original purchaser (“Purchaser”) against defects in materials and workmanship for a period of one (1) year from the date of purchase. Should a Product fail due to manufacturing defects, it will be repaired, without charge, or replaced by a materially equivalent Product, at Euro’s sole discretion. Notwithstanding the preceding, Euro further expressly reserves its right to refund the purchase price paid for any failed Product as its sole and exclusive warranty remedy.

This warranty expressly excludes damages caused by accident, improper care, negligence, normal wear and tear, modification, improper installation and/or installation of the Product in any unapproved manner or in a manner which may otherwise influence the function and/or the performance of said Product, overloading of the Product, use of the Product under extreme or abnormal conditions, either intentionally or by error, or otherwise resulting from improper storage or transport and/or from natural breakdown of colors and materials over an extended time.

This warranty policy supersedes all prior warranty policies and SHALL CONSTITUTE THE SOLE AND EXCLUSIVE WARRANTY PROVIDED BY EURO WITH RESPECT TO THE PRODUCT, IN LIEU OF ANY AND ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, ARISING BY OPERATION OF LAW OR OTHERWISE. ALL IMPLIED WARRANTIES, INCLUDING BUT NOT LIMITED TO THE WARRANTIES OF MERCHANTABILITY, NON-INFRINGEMENT AND FITNESS FOR A PARTICULAR PURPOSE, ARE HEREBY EXCLUDED. IN NO EVENT SHALL EURO BE LIABLE FOR ANY LOSS OF REVENUE OR PROFITS, LOSS OF USE OF EQUIPMENT, OR OTHER CONSEQUENTIAL OR INCIDENTAL DAMAGES RESULTING FROM THE USE, INSTALLATION, PERFORMANCE OR FAILURE OF ITS PRODUCTS.

This warranty shall be governed by the law of the Province of Ontario in regard to Products sold in Canada, and the United States of America, without regard to any conflicts of law principles. The Purchaser agrees that the United Nations Convention on Contracts for the International Sale of Goods and the United Nations Convention on the Limitation Period in the International Sale of Goods shall not apply to sales of the products covered by this warranty.
